That said Officers/Directors shall serve for two years or from July 1, 2023 to June 2025 as per Section 4, Article V of the SFTMHOAI by laws unless a Director/Officer resigns, or is remove from office, or is disqualified and/or The Board or dissolve by two thirds of the association's members, and/or until their successor have been elected.
